The institution has implemented an extensive use of technology enabled teaching and learning process (Digital SMART class room) which consist of Smart boards, Laser Disc Projectors, Multi-media projectors that provides a real time experience to students in various subjects through interactive sessions, videos and 3-D graphics. Beyond the syllabus, extracurricular activities such as arts, sports, tech fests, expo, etc. are designed and implemented in the academic calendar to make the students competitive in the professional world and to make them respond to social and national obligations. Bridge courses are conducted to make the students to follow the curriculum without any difficulty. Students are encouraged to participate in national level paper contests, seminars and project exhibition competitions. Students who are interested in Research and Development work are continuously motivated and encouraged to present their Project/Research work in different National/International Industrial visits are arranged so that students can get practical exposure on the subjects of curriculum. Suitable lab experiments are designed as per curriculum and

conducted to make the students to understand the concept more effectively. Beyond syllabus, additional relevant components like engineering ethics, social responsibilities and management skills and language lab are included in the academic curriculum.
